


This report explores public opinion of air and water quality issues for Onslow County (North Carolina) residents who live within five miles of an industrial animal farm (that houses at least 2,500 hogs and at least 125,000 chickens), or what some refer to as concentrated animal feeding operations (CAFOs).

Over 5,000 residents were contacted via postcard and invited to participate in a survey on air and water quality. In total, 162 individuals provided completed responses by scanning the QR code (or typing the web address listed) on the postcard. This report provides a summary of the survey's major findings. It also includes a selection of openended responses that highlight the experiences of several respondents. For more information on the survey methodology, see the Appendix.

### **Key Findings**

- Most respondents are positive in their evaluations of the air quality where they live.
  - Specifically, a majority of respondents (55 percent) rated that the quality of the air in the area where they live current as "excellent." An additional 25 percent answered that the air quality is "good."
  - A combined 16 percent reported the air quality where they live as "fair" (8 percent) or "poor" (8 percent).






- Some respondents offered additional thoughts that indicate air quality can vary. Three examples include:
  - "It depends. One day the entire town can reek of manure and the next day it seem[s] ok[ay]."
  - "With the trees around there isn't any smell. The only time there is is if you drive by one. ...".
  - "Some days the odor is horrible. It varies depending on what they are doing...".

### • Most respondents report rarely or never noticing unpleasant smells or odors in the air near their home.


- Specifically, a plurality of respondents, 40 percent, reported "rarely" noticing unpleasant smells or odors in the area in which they live, while another 28 percent answered "never."
- A combined 12 percent said that they "always" (2 percent) or "frequently" (10 percent) notice unpleasant smells or odors in the area in which they live.
  - Those in lower household income ranges were the most likely to answer that they "always" or "frequently" notice unpleasant smells or odors in the area in which they live. One-third (33 percent) fell into the "always" or "frequently" category among those in households with annual incomes of \$50,000 or less; 21 percent for \$50,000 to \$99,999; an 0% for \$100,000 or higher.



### How frequently, if at all, do you notice any unpleasant smells or odors in the air near your home?


# • Approximately two-thirds of respondents (67 percent) believe that large industrial animal farms have had no impact on the air quality near their home.

 Among those who answered that large industrial animal farm have had a "positive" or "negative" impact, responses were almost evenly divided (with 15 percent that answered "negative" and 14 percent that answered "positive").




#### What impact, if at all, do you think large industrial animal farms or CAFOs have had on the air quality near your home?

- A few respondents offered additional nuance. Two examples include:
  - "[A]t times it is a negative impact [and] at times it doesn't seem to impact air quality."
  - [W]e spend more time indoors when the wind comes from the chicken farm directions."
- A majority of respondents rates the cleanliness of the water in the rivers and streams near where they live as clean or very clean.
  - Specifically, a combined 75 percent answered "very clean" (38 percent) or "more clean than not clean" (37 percent). By comparison, a combined 16 percent evaluated the cleanliness as the water in the rivers and streams near where they live as "more not clean than clean" (10 percent) or "not clean at all" (6 percent).




#### How would you rate the cleanliness of the water in the rivers and streams near where you live?

- Of the 9 percent who answered "other," respondents shared some additional comments. Three examples include:
  - "Very clean to the point that growing up we swam and played in the creeks and ponds [sic]."
  - "Much [c]leaner than the water in rivers and streams near new housing developments and urbanized areas. The water released from 'urban water treatment' facilities has me very concerned for water quality in those areas compared to where we live."
  - "How could you even tell the water quality?"
- Most of respondents (56 percent) believe that large industrial animal farms have had no impact on the cleanliness of the water in the rivers and streams near where they live.
  - Of the remaining respondents, more answered that there has been a "positive impact" (24 percent) than a "negative impact" (13 percent).



#### What impact, if at all, do you think large industrial animal farms or CAFOs have had on the cleanliness of the water in the rivers and streams near where you live?


- Most respondents have a positive evaluation when rating the quality of their drinking water where they currently live.
  - Specifically, a majority of respondents (51 percent) rate the quality of their drinking water as "excellent." An additional 35 percent rate the quality of their drinking water as "good."
    - Among those who get their drinking water from a private well, twothirds (67%) rated their drinking water as "excellent" compared to 39 percent who do not get their drinking water from a private well.
  - A combined 13 percent rated their drinking water as "fair" (9 percent) or "poor" (4 percent).

# • Few respondents report any unpleasant smells from the water that comes from their home.


- Just 3 percent of respondents combined reported "always" (1 percent) or "frequently" (2 percent) noticing an unpleasant smell from the water that comes from their home.
- A combined 90 percent answered "rarely" (15 percent) or "never" (75 percent) having an unpleasant smell coming from the water that comes from their home.



# How frequently, if at all, does the water coming from your home have an unpleasant smell to it?

## • Finally, most respondents do not think that large industrial farms have had an impact (positive or negative) on the water quality coming from their home.

- Approximately 77 percent answered "no impact" on whether large industrial animal farms have affected the water quality coming from their home.
- Of the remaining responses, 11 percent answered "positive," 7 percent answered "negative," and 5 percent answered "other."

### Appendix

### Information About the Survey

Coastal Carolina Riverwatch contracted with East Carolina University's (ECU) Center for Survey Research (CSR) to conduct a survey of adults (i.e., 18 years of age or older) in Onslow County, North Carolina who live within five miles of an industrial animal farm (that house at least 2,500 hogs and at least 125,000 chickens), or what some refer to as concentrated animal feeding operations (CAFOs). Potential respondents were contacted once by mail through a postcard that requested voluntary participation in the survey. In total, there were 5,952 postcards mailed. The survey opened on July 24, 2023, and closed on September 1, 2023. During that period, 162 people completed the survey for a response rate of 3 percent. Respondents completed the survey online either through a QR code or a web address provided on the postcard.
